## How to remember our organization in your estate plan

The enclosed wording is for educational purposes only. There are many ways to structure and achieve your charitable and tax objectives. It is always best to review any changes in your Will with an attorney to make sure that the change is consistent with your entire estate plan.

Three of the most popular forms bequests can take are:

A fixed amount of money: "I give to the Central Pennsylvania Festival of the Arts, federal tax identification number 25-1205389, located in State College, PA, \$"
A percentage of the estate: "I give to the Central Pennsylvania Festival of the Arts, federal tax identification number 25-1205389, located in State College, PA,% of my estate."
A residual bequest: "I give all the residue of my estate, including real and personal property, to the Central Pennsylvania Festival of the Arts, federal tax identification number 25-1205389, located in State College, PA.
If you wish to have your bequest applied to a specific program, simply add "for the benefit of (name of program)" to the language suggested above.
Consult an attorney when preparing legal documents.

Written documentation of your bequest is <u>not</u> required for Celebrations Circle membership. However, if you wish to provide us with documentation, you need send only a copy of the page from your Will, living trust or other legal document that references your gift and a simple identification of the document itself such as the first page. Doing so will help us both to plan for the future and to insure that your wishes are carried out.
